Policy on Materiality of Related Party Transactions

1. Preface

The Board of Directors (the "Board") of Golden Tobacco Limited (the "Company") has adopted the following Policy (the "Policy") to determine Materiality of Related Party Transaction and also dealing with Related Party Transactions.

The Policy has been formulated in order to comply the provisions of the Companies Act, 2013 ("the Act") and the Rules framed there under and Regulation 23 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations").

2. Objective of the Policy

This Policy has been framed to provide the governance framework for Related Party Transactions to be entered into by the Company with the RelatedParties.

3. Definitions

- a. "Arm's Length Transaction" means a transaction between two related parties that is conducted as if they were unrelated, so that there is no conflict of interest.
- b. "Audit Committee or Committee" means a Committee of Directors of the Company, as constituted fromtimetotimeunderSection177oftheCompaniesAct,2013read with Regulation 18 of SEBI LODR REGULATIONS.
- c. "Board of Directors" or "Board" means the Board of Directors of the Company, as constituted from time to time.
- d. "Related Party"shall have the meaning ascribed to it in the Act and SEBI LODR REGULATIONS and includes all amendments and modificationsthereof from time to time.
- e. "Related Party Transaction/s" or "RPT" shall have the meaning ascribed to it under Regulation 2(zc) of SEBI LODR REGULATIONS read with Section 188(1) of the Actincluding all amendments and modifications thereof from time to time.
- f. "Material Related Party Transaction/s" is / are defined under Regulation 23 of SEBI LODR REGULATIONSand Section 188 of the Companies Act, 2013 read with Rule 15 (3) of the Companies (Meetings of Board and its Powers) Rules, 2014 as under:

Regulation 23 of SEBI LODR REGULATIONS

A transaction with a Related Party shall be considered material if the transaction (s) to be entered into individually or taken together with previous transactions during a Financial Year, exceeds ten percent of the annual consolidated turnover of the Company as per the last Audited Financial Statements of the Company.

A transaction involving payments made to a related party with respect to brand usage or royalty shall be considered material if the transaction(s) to be entered into individually or taken together with previous transactions during a financial year, exceed two percent of the annual consolidated turnover of the listed entity as per the last audited financial statements of the listed entity.

Rule 15 (3) of the Companies (Meetings of Board and its Powers) Rules, 2014

Contracts or arrangements with respect to the transaction /s with Related Party as defined under Section 188 (1) (a) to (e) of the Companies Act, 2013 shall be material if they are as per criteria mentioned below:

- i. sale, purchase or supply of any goods or material directly or through agent, amounting to ten percent or more of the Turnover of the Company or Rupees One Hundred Crore, whichever is lower, as mentioned in clause a) and clause e) respectively of sub-section (1) of Section 188;
- ii. selling or otherwise disposing of or buying property of any kind, directly or through agent amounting to ten percent or more of Net Worth of the Company or Rupees One Hundred Crore, whichever is lower, as mentioned in clause b) and clause e) respectively of sub-section (1) of Section 188;
- iii. leasing of property of any kind amounting to ten percent or more of the net worth of the Company or ten percent of Turnover of the Company or Rupees One Hundred Crore, whichever is lower, as mentioned in clause c) of sub-section (1) of Section 188;
- iv. availing or rendering of any services directly or through agent, amounting to ten percent or more of the TurnoveroftheCompanyorRupeesFiftyCrore,whicheverislower,asmentionedinclaused) and clause e) respectively of Section 188;
- v. appointment to any office or place of profit in the Company or its Subsidiary Company or Associate Company at a monthly remuneration exceeding Rupees Two Lac Fifty Thousand as mentioned in clause f) of sub-section (1) of Section 188;or
- vi. remuneration for underwriting subscription of any securities or derivatives thereof of the company exceeding one percent of the Net Worth as mentioned in clause g) of sub-section (1) of Section 188;

Explanation

It is clarified that the limits specified in i to iv shall apply for transaction/s to be entered into either individually or taken together with previous transactions during a Financial Year.

The Turnover and Net Worth referred above shall be on the basis of the Audited Financial Statement of the preceding Financial Year.

4. Procedure for approval of Related Party Transactions

a. All Related Party Transactions or any subsequent modifications of such transactions shall require prior approval of the Audit Committee. However, the Audit Committee may grant omnibus approval for Related Party Transactions proposed to be entered into by the Company for a period not exceeding one year subject to the following conditions:

- The Audit Committee shall lay down the criteria for granting the omnibus approval in line with this Policy and such approval shall be applicable in respect of transactions which are repetitive in nature.
- The Audit Committee shall satisfy itself with the need for such omnibus approval keeping in view the interest of the Company;
- The Audit Committee shall specify in the omnibus approval
 (i) the name/s of the Related Party, nature of transaction, period of transaction, maximum amount of transaction that can been there into,

(ii) the indicative base price / current contracted price and the formula for variation in the price, if any.

In case the need for Related Party Transaction cannot be foreseen and the details are not available, the Audit Committee may grant omnibus approval for such transactions subject to their value not exceeding Rs.500crores per transaction. The overall threshold limits for related party transactions shall be Rs 1000 crores per annum to reviewed by Audit Committee every three years and approved by the Board on the recommendation of the Audit Committee.

The Audit Committee shall review, at least on a quarterly basis, the details of RPTs entered into by the Company pursuant to each of the omnibus approvalgiven.

b. All Related Party Transactions which are in Ordinary Course of Business and approved by the Audit Committee shall be placed before the Board to take note of thesame.

All Related Party Transactions which are either not (a) in the ordinary course of business or (b) on arm length's basis shall require prior approval of the Board.

d. All Material Related Party Transactions which are exceeding the limit prescribed above in Clause 3 of this Policy shall not be entered into except with the prior approval of the Board and the Shareholders of the Company by way of Resolution.

e. All Related Party Transactions or Material Related Party Transactions entered into by the Company without consent of the Board or Shareholders by a resolution in General Meeting shall be ratified within a period of three months from the date of such transactions.

4. Communication of this Policy

A copy of this Policy shall be handed over to the Directors of the Company within one month from the date of approval by the Board or Committee, as the case may be. This Policy shall also be posted on the website of the Company and a web link thereto shall be provided in the Annual Report of the Company.

5. Amendment

Any change in the Policy shall be approved by the Board of Directors of the Company or any committee authorised by the Board. The Board of Directors or such committee as authorised by the Board shall have the right to withdraw and / or amend any part of this Policy or the entire Policy, at any time, as it deems fit, or from time to time, and the decision of the Board or such committee as authorised by the Board in this respect shall be final and binding.
